About the New Jersey Clean Energy Program (NJCEP):

Provides financial and other incentives to the State's residential customers, businesses, local governments and schools that install high-efficiency or renewable energy technologies, thereby reducing energy usage, lowering customers' energy bills and reducing environmental impacts. In totality over the last fifteen years, New Jersey has invested more than \$3.1 billion in approximately 1.5 million energy saving projects that have reduced electric use by approximately 7% - enough energy savings compounded over 15 years to power about 3.1 million homes. The program is authorized and overseen by the New Jersey Board of Public Utilities (NJBPUB), and its website is www.NJCleanEnergy.com.
