NJBPU APPROVES CLEAN ENERGY PROGRAM BUDGET

The New Jersey Board of Public Utilities approved the funding levels for the NJCEP FY21 budget. In addition to existing clean energy programs, the FY21 budget includes \$1.5 million to support a new Acoustical Testing pilot program for water utilities that facilitates their purchasing or renting of monitoring systems to locate water leaks. This program primarily seeks to address water and energy losses, especially in overburdened communities.
